## OVERVIEW

In the applications to be made to Polimer Arge within the scope of the Law on the Protection of Personal Data, in accordance with Communiqué on Application Procedures and Principles to Data Controller Published in the Official Gazette No. 30356, dated 10.03.2018. the name, surname of data subject and signature if the application is written, turkish republic identification number for citizens of the Republic of Turkey, nationality and passport number or if any, identification number for foreigners, address of residence or workplace for notification, e-mail address for notification, telephone and fax number, and the subject of the request are mandatory.

**In order to respond to your requests in a healthy way, it is important that your request content is clear, understandable and historically determinable. For this reason, the information and documents requested by you with this application form must be filled in completely and correctly and an application must be made to the Company in the following ways.**

### Written Applications

Written applications to be made to the Company indicate that a original signed copy of this "Application Form", which contains the above information and is filled in completely, is authorized to make an application to the address of the Company in person or regarding the rights listed under article 11 of KVKK and must be submitted by power of attorney with a notarized power of attorney or through a notary public by sending to the address of KALEAĞASI SOK. In addition, if the transaction requires an additional cost, according to Article 7 of the Communiqué on Application Procedures and Principles to Data Controller, no fee will be charged up to ten pages; For each page over ten pages, a transaction fee of 1.00 Turkish Liras will be charged.
